At the last meeting, BoS agreed to investigate activities/initiatives concerning mandatory activities. Dorthe has enquired with Learning Support (LS) and the Dean of Education (DoE):

*“DoE has investigated Mandatory Activities in connection with student wellbeing and workload, primarily based on input from students. The situation has been discussed with Heads of Study Programme. DoE has urged study programmes, primarily programmes from Department of Computer Science, to decrease activities (including Mandatory Activities) that increase student workload. There does not seem to be pedagogical or didactic grounds for using Mandatory Activities. Thus, the next step is to ask Heads of Study Programme to deliver data on which kinds of students benefit from Mandatory Activities and reflect on which kinds of students are negatively affected by Mandatory Activities and how big a proportion of the student group they comprise (both those who benefit and those who are negatively affected).”*
