2. Course Evaluation spring 2023

SAT went over the feedback to the courses.

Data-Driven Design and Development

Paolo: There is a trend of mismatch between expectations. Maybe the title is slightly misleading? Students are expecting to do something else than the course is. We will focus more on explaining what the course is and setting expectations and motivation earlier would be good. Some students just do not find it interesting, and it is a balance between student interests and what we as the programme think they should learn. We are changing teachers next time as the former PTL got a full-time job. We will also consider recording the lectures and the exam description will be updated.

Foundations of Game AI

Sebastian: There is a disconnect between the lectures and the exercises. There is a better integration between the two in Deep Learning so will try to do this here too. Good idea to have a TA that has done the course before. The course is mandatory from spring 2025.

Game World Design

Game World Design scored very, very high, but there were a few comments to this course too. SAT discussed the difficulty in group forming and the size of the teams. Maybe smaller teams can help with the scoping, but the class has many participants so smaller teams will be difficult to manage. The big challenge is about setting expectations and ambition management. Also, a focus on roles and responsibilities and maybe even describe roles in the course description.
