GBI

Course evaluations → *Entrepreneurship and Business Decisions*: we have received a complaint on this elective, the score is low and learning outcomes are very similar to Business Foundations. All of this has been taken into consideration, and we have made changes to the selection of electives from GBI in the autumn semester. Entrepreneurship and Business Decisions have been cancelled and a new elective, Digital Platforms, will take its place.

Managing Sustainability: the teachers have tried to focus on a more practical approach to the subject based on earlier feedback for the course. This has left the students missing a theoretical background and the teachers are already working on improving this for next semester.

Organisation and Process Theory: A demanding course which may cause the low score. It can be difficult for the students to relate to this subject. Oliver has arranged a meeting with the teachers to suggest some pedagogical tools to consider.

Supervision evaluations → Student response looks good, but supervisor response is a bit low. The supervision agreement might not be helpful for the process of writing a thesis or bachelor project but is more of an official statement and extra form to fill out.

DIM: We will discuss it at next SATBUSS meeting, since Head of Programme is not present.

Comments for Board of Studies:

- Guidelines for standard page and body sizes of exam submissions is only used as recommendations by the teachers. This causes confusion among the students since the number of pages and how to define a standard page is different from course to course.
SATBUSS proposes a discussion of this and suggests a framework for standard pages (text, pictures, tables, code etc.) which is not just a guideline but a principle to base all submission sizes on.

- The supervision agreement is not helpful for the supervisors and in most cases it is only a formal issue to attend to. SATBUSS asks the Board of Studies to discuss an update or different solution for this.
