### 5. Renaming of course: Mobile and Distributed Systems on SWU and SD. / Marco

Change of title to Distributed Systems.

Reasons:

- 2) Some students often misinterpret the title; by thinking, that mobile refers to mobile phones.

Dan and Søren recommend the change.

A SAT member, who took the course, finds the new title suits what happens in the course. SAT recommends the change.

6. Application for X-form examination for DS course. Appendices 6a and 6b.

SAT discussed the proposal and have the following comments:

- Previously, one SAT member took the course with the proposed X-form, which worked really well.
- The workload on this course aligned well with the other courses on second semester.
- If Administration is happy with this examination form, SAT finds no reason to suggest any changes, as it seems to please both students and teachers.

## 7. Replacement of mandatory modules for SD in SAT CS. / Søren
